At the time of registration, students and their parents are given an undertaking that he/she shall not indulge in the unlawful act of ragging. PUNISHABLE INGREDIENTS OF RAGGING	PUNISHMENTS
<ul style="list-style-type: none"><li>• Abetment to ragging;</li><li>• Criminal conspiracy to rag;</li><li>• Unlawful assembly and rioting while ragging;</li><li>• Public nuisance created during ragging;</li><li>• Violation of decency and morals through ragging;</li><li>• Injury to body, causing hurt or grievous hurt;</li><li>• Wrongful restraint;</li><li>• Wrongful confinement;</li><li>• Use of criminal force;</li><li>• Assault, as well as sexual offences or unnatural offences;</li><li>• Extortion, criminal trespass;</li><li>• Offences against property;</li><li>• Criminal intimidation;</li><li>• Attempts to commit any or all of the mentioned offences against the victims (s)</li><li>• Threat to commit any or all of the above mentioned offences against the victim (s)</li><li>• Physical or psychological humiliation;</li><li>• All other offences covered under the definition of "Ragging".</li></ul>	<ul style="list-style-type: none"><li>• Suspension from attending classes &amp; academic privileges.</li><li>• Withholding/ withdrawing Scholarships/ fellowship and other benefits.</li><li>• Debarring from appearing in any test/ examination or other evaluation process.</li><li>• With holding results.</li><li>• Debarring from representing the Institute in any regional, national or international meet, tournament youth festival ,etc.</li><li>• Suspension/ expulsion from the hostel.</li><li>• Cancellation of admission.</li><li>• Rustication from the Institution for period ranging from 1 to 4 semesters.</li><li>• Expulsion from the Institution and consequent debarring from admission to any other institution for a specific period.</li><li>• Fine ranging between Rs. 25,000 to Rs. 1 Lakh.</li><li>• An F.I.R. will be lodged against the culprit (s) as per Supreme Court of India &amp; MoE, Government of India directives.</li></ul>
